PUBLICATION AGREEMENT

The purpose of this agreement is to set forth the understanding between you and the Rocky Mountain Mineral Law Foundation (“Foundation”) in connection with the presentation and publication of your paper (“Paper”) and the PowerPoint or similar slides used in presenting the Paper (“Presentation”) at the 63rd Annual Rocky Mountain Mineral Law Institute, July 20–22, 2017 (“Institute”).

You will own the copyright in the Paper, and the Foundation will own the copyright in the compilation of the *Proceedings* of the Institute.

As the owner of the copyright in the Paper, you will have the right to publish the Paper and revisions and modifications thereto in other publications and in any format, whether now known or hereafter developed, provided that (a) you will not so publish the Paper until after the *Proceedings* from the Institute have been published and distributed, and (b) you identify in any such publication that the Paper was originally published as part of the *Proceedings* of the Institute in a form such as: “This paper was originally published by the Rocky Mountain Mineral Law Foundation in the *Proceedings* of the 63rd Annual Rocky Mountain Mineral Law Institute (2017),” or “This paper is a revision of a paper entitled ‘[Title]’ originally published by the Rocky Mountain Mineral Law Foundation in the *Proceedings* of the 63rd Annual Rocky Mountain Mineral Law Institute (2017),” or words of similar import.

The Foundation will have (a) the perpetual, nonexclusive, royalty-free license to publish the Paper in the Institute manual and in the *Proceedings* of the Institute and to republish the Paper in any format, whether now known or hereafter developed, provided, however, that any such publication identifies you as the author; (b) the perpetual, nonexclusive, royalty-free license to publish the Presentation in the Institute manual; and (c) the right to authorize users of Foundation publications to reproduce and distribute the Paper to the extent deemed appropriate by the Foundation.

You represent and warrant that (a) you have the right to enter into this agreement; (b) except as may be explained in any attachment that you append to this agreement, the Paper and the Presentation are your original work of authorship; (c) the Paper and the Presentation and the publication thereof as contemplated hereby will not violate or infringe any copyright, trademark, right of privacy or publicity or other proprietary right of any person or entity; and (d) to the extent the Paper or the Presentation contains any material that requires written permission to be published as contemplated hereby, you have obtained such permission from the appropriate parties.
